Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Assistant Treasurer, Women University Mardan, Mardan's Tender Notice for Supply of Stationary Items.

This is with reference to Women University Mardan, Mardan's Tender Notice, published in daily "The News" on 15th February, 2019. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per advertisement, the tender submission date is on 04-03-2019, while the tender opening date is kept on 05-03-2019. Therefore, the advertisement is in violation of KPPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Bids documents can be obtained from the office of the Treasurer, Women University Mardan, (in official hours 8:00Am to 4:00Pm) by depositing bid document fee of Rs.1000/- in the Women University Mardan account No. 15702-00-1 at The Bank of Khyber, Chamber House Branch, Mardan, or in the shape of demand draft in favor of Vice Chancellor, Women University Mardan.

Bid security /earnest money @ 2% of the total bid value must be submitted along with the financial bid, in the shape of call deposit receipt (CDR) in favor of Vice Chancellor, Women University Mardan. Income tax, GST, stamp duty, professional tax, or any other government tax will be charged as per government rules. The rates approved will remain effective for six month from the date of opening of technical bids.

The technical bids must provide the following information:

1. Valid National Tax Number & sales tax registration certificate

from the Federal Board of Revenue.

2. Certificate to the effect that bidder is on the Active Tax Payer's list of the FBR.
3. Technical Specification/broachers of the items.
4. List of similar nature of jobs along with completion certificates.
5. Yearly business turnover.
6. Regional set up / office in Khyber Pakhtunkhwa.
7. Certificate on stamp paper properly attested by the notary public showing that the firm has never been black listed or debarred by any government department.
8. Certificate on stamp paper properly attested by the notary public showing that the firm is not involved in any litigation with respect to their services.
