Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Assistant Engineer/Assistant Director, LG & RDD, Charsadda's Tender Notice for Construction of Street Pavement.

Dear Sir,

This is with reference to LG & RDD, Charsadda's Tender Notice, published in daily "Aaj" on 15th May, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of technical proposals is given as 24-05-2017, which is 5 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- All the tenders/bidding shall be done on "Percentage above/below" system.
- The Work Order will be only and only issued pertaining to the revival of the surrendered amount for District ADP (2015-16) and CMD (2015-16) for the schemes
- The following shall be attached with the bids: (i) Enlistment and Renewal Copy in LGE&RDD Department for the Year 2015-16 (ii) Photocopy of CNIC (iii) Power of Attorney (if applicable)
- Cost of tender form/documents mentioned in the website is payable through Demand Draft and Pay Order (Non-refundable) in the name of Assistant Director, LG&RDD, Charsadda.
- The 2% Earnest Money is mentioned against each work, shall be received in the shape of Call Deposit from scheduled bank in the name of Assistant Director, LG&RDD, Charsadda, which shall accompany with the tender documents along with stamp duty.
- The contractors/bidder who quotes their bids/rates more than 10% below Engineering estimate shall submit an additional security in the form of call deposit in the name of Assistant Director, LG&RDD Charsadda equal to 8% of the Bid cost.
- After commencement of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
- Tender documents of bidders if found with bogus/fake documents will be rejected and their registration shall stand cancelled/blacklisted in addition of forfeiture of earnest money.
- Incomplete bids or without 2% earnest money shall not be accepted.
- Cutting/Over writing in the BOQ/Contract will be termed as defective.
- The limits for below rates shall be followed as per Government rules.
- The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by a person or persons duly authorized to sign. All pages of the bid/tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.
- Original tender documents in sealed envelope should reach to Assistant Director, LG&RDD, Charsadda while copy of the same documents should reach to the Director General, LGE&RDD, Peshawar, KPK through courier. No tenders are acceptable through Fax/by hand.
- Sealed bids sent through registered mail/couriers service should reach upto the specified time and date, and will be opened in presence of bidders/representatives. In case of tender not opened on the above mentioned date, because of any unforeseen reason, the tender shall be opened on the next working date at same place and time.

- The Completion period would be as per Work Order.
