and Services Rules 2014, Assistant Engineer/ Assistant Director, LG & RDD,
Charsadda's Re- E-Tender Notice for Constructions Works.**

This is with reference to LG & RDD, Charsadda's Re-E-Tender Notice, published in daily "Aaj" on 17th December, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of bids is on 28-12-2017, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***34. Response time.** - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the E-tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

(1). All the bidding will be through E-bidding system. Tender Form & BOQs can be filled and downloaded by the original contractor available on the official website of LG&RDD, DG Office (www.lgko.gov.pk) Khyber Pakhtunkhwa after one day of publishing of NIT in newspaper. (2). The contractors are required to fill the tender form and BOQ online and submit a hard copy of the same tender to the office of Assistant Director, LG&RDD, Charsadda. The original and duplicate copies of tendered documents clearly marked as original and duplicate in the name of concerned Nazim VC/NC and Assistant Director, LG&RDD respectively (sealed in one envelope) must be submitted to the Assistant Director, LG&RDD Charsadda Office. The tender documents must reach this office up to fixed date and time as mentioned. (3). The following documents must be attached with bids: (i). Enlistment and renewal copy in LG&RDD for the year 17-18. (ii). Attested Photocopy of CNIC. (iii). Power of Attorney (if applicable). (iv). Pakistan Engineering Council (PEC). (4). Tender documents of bidder if found bogus/ false documents will be rejected and their registration shall stand cancelled/ black listed in addition of forfeiture of earnest money and security amount (if any). (5). No tenders are acceptable through fax/ by hand. Sealed bids sent through registered mail/ courier service should reach up to the specified time and date. The contractor or his representative may be present at the time of opening of tender. (6). Any contractor/ firm are bound to mention rates as per notification No. KPPRA/M&E/Estt/1-2016 "Above/ Below System". (7). The bidder who offer their bid more than 10% below of the estimate cost will have to enclose additional 8% call deposit of the estimated cost in original in the name of concerned Nazim, VC/NC alongwith tender documents otherwise the bid will not be entertained. (8). In the case the bid becomes a tie the contractor shall be decided through a free toss which shall be binding and final. (9). The time limit of each work shall be as per work order issued to successful bidder and the contractor will have to start the work within 15 days' time period after the issuance of work order failing which the work will be cancelled and security/ additional security (if any) will be forfeited. (10). All Federal and Provincial duties, stamp duty and taxes including sales tax will be recoverable as per directives of the Government issued from time to time. (11). The procuring entity may reject any or all bids after communicating the reasons for rejection at any time prior to the award of contract. (12). Any addition made in terms & conditions in the NIT advertised in the newspaper will be implemented as per KPPRA Rules. (13). The 2% Earnest Money for the work shall be submitted in shape of original call deposit/ CDR in the Name of concerned Nazim Village/ Neighbourhood Council. (14). Unauthorized persons will not be allowed to participate in the tender process. (15). Any other information/ conditions can be obtained from the office of the undersigned on any working day. (16).
