Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director, Directorate of Culture, Peshawar's Tender Notices for Interior Designing & Renovation Works.

Dear Sir,

This is with reference to Directorate of Culture, Peshawar's Tender Notice published in daily "Mashriq" on 16th November, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, it is mentioned that "The Department reserves the right to reject any or all bids without assigning any reason". It is violation to KPPRA Rules 2014, Page 21. The Rule is quoted below for your reference:


Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

- iii. Bids must be delivered to the undersigned on or before 30-11-2015 up to 1400 hours. Bids received late will not be considered and rejected.
- iv. Bids will be opened at 14:30 hours on the same day i.e. 30-11-2015 in the presence of the bidder / duly authorized bidder's representative who choose to attend the bid session.
- v. Interested firms may obtain tender documents on payment of Rs.1000/- non-refundable on the written request during office hours from the office of Director, Directorate of Culture, Khyber Pakhtunkhwa, Peshawar. Tel: 091-9210264-9214211
- vi. Both "Technical Bids" and "Financial Bids" must be submitted in two separate sealed inner envelopes marked "1-Technical Bids" and "2-Financial Bids" which should be packed in one outer envelope. The bid security must be enclosed with "Technical Bids".
- vii. The specifications of the job are attached with the tender documents.
- viii. The bidder shall furnish an affidavit on Rs.100/- Stamp paper to the effect that the firm is not black listed in any Government Department and no suit with any purchaser is pending in any court of law.
- ix. Conditional, incomplete, unsigned and bid filled with led pencil will not be accepted.
- x. Usage of cutting, omission, correction fluid & corrections are strictly prohibited unless duly initiated.
