Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Education Officer (Males/Female), Charsadda's Tender Notice for Supply of Furniture.

Dear Sir,

This is with reference to District Education Office (Males/Female), Charsadda's Tender Notice published in daily "Mashriq" on 16th November, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

1. As per advertisement, "the last date for submission of sealed tenders is given on 05-12-2015, while the opening of bid is kept on 07-12-2015", which is violation of KPPRA Rules 2014, Page 18 'Submission of bids' Clause. The Rule is stated as under;

Submission of bids.--- (3) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

2. Also, it is mentioned that, "The procuring authority has the right to cancel one or all bids at any stage without assigning any reason". It is violation to KPPRA Rules 2014, Page 21. Stated as under:

Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

5. Unsealed and incomplete Bjd Documents will be rejected.
6. Tenders should consist of Income Tax clearance certificate for the year 2014-15 other wise tender will be rejected.
7. 2% Call Deposit will be obtained from the concerned dealer/contractor on the spot on acceptance of their bids.
8. There will be Two Envelop for Tender Documents i.e Technical Proposal & Financial Proposal.
9. If a dealer or his representative failed to present at the opening day of bids their tender will be con considered as cancelled automatically.
