Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C & W Division, Kohat's Tender Notice for Construction Works.

Dear Sir,

This is with reference to Executive Engineer, C & W Division, Kohat's Tender Notice, published in daily "Mashriq" on 14<sup>th</sup> October, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, "only the last date & time of closing of bids is mentioned in the advertisement, without stating the date & time of opening of bids that shall be on the same day". It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;


*Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received  
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

*Mis-procurement.— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
