Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Nazim/ Secretary, Village Council/Neighborhood Council Suleman Tab, District Kohat's E-Tender Notice for Construction of PCC Street Pavement.

Dear Sir,

This is with reference to VC/NC Suleman Tab, District Kohat's E-Tender Notice published in daily "Aaj" on 17<sup>th</sup> October, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 25-10-2016, which is 6 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***34. Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the e-tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The sealed tender should reach the office of concerned council as mentioned above on or before the opening date/time given against each work. 4. The following documents are required to be submitted with the application/ tender form, i. Earnest money to the extent of 2% in the shape of deposit at call in the name of concerned Nazim along with stamp duty. ii. Enlistment copy and renewal with LG&amp;RDD for the current year. iii. CNIC copy of the bidder. iv. Copy of registration and renewal of Pakistan Engineering Council for the current year. v. Power of Attorney if applicable. 5. Bidders found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher ups for black listing. 6. The contractors/ firms have to start works immediately (within one week), after the issuance of work orders. Otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process. 7. The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or submitted a bid or proposal, the ground for rejection of all bids or proposals as per KPPRA Rules. 8. All the government taxes will be deducted as per prevailing government policy. 9. All pages of the Bid/tender Documents shall be initiated and official seal be affixed by the person or persons signing the bid. 10. Any cutting / overwriting on the BOQ will be liable to rejection of the tender and will be declared defective. 11. Tenders / bids should reach the office of the concerned council as mentioned above through courier / registered post before the opening time. No tenders are acceptable through fax or by hand. 12. Responsibility of late delivery will not rest upon this office. 13. The duplicate copy of the sealed tender must be sent to concerned Assistant Director LG &amp; RDD office for record purpose before the closing date and time of the tender. 14. Any addition made in Terms and conditions in the NIT advertised in the newspaper will be implemented as KPPRA Rules / Govt policies. 15. The contractors who offer quoting the rates, more than 10% below on the engineering estimate/BOQ shall attach additional earnest money with the bid @ 8% of the offered rates as "below" otherwise the bid shall be treated as rejected and 2% earnest money already deposited will be forfeited and offer should be made to the 2nd lowest, 3rd lowest as the case may be. 16. In case bids become tie, the award of contract shall be decided through a free toss which shall be binding and final. 17. The work orders shall only be issued against the volume of funds available with VCs/NCs during current financial year for VCs/NCs schemes. 18. Sealed bids sent through registered mail/couriers service should reach up to the specified time and date as mentioned above at the above mentioned address of VC/NC. 19. Sealed bids will be opened in presence of bidders/ authorized representatives in the office of the VC Nazim. In case of tender not opened on the above mentioned date, because of any unforeseen reasons, shall be opened on the next working date at the same place and time. 20.
