Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Deputy Director (Safe City Project), Peshawar Development Authority (PDA), Peshawar's EOI Notice for Hiring of Security Company for Providing Security Services.

Dear Sir,

This is with reference to Peshawar Development Authority (PDA), Peshawar's Tender Notice, published in daily "The News" on 30th November, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, "Number of guards can be increased or decreased on demand of client", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPPRA Rules 2014, Rule No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under:

10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:

(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:

Provided that it does not exceed fifteen percent of the original contract value;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.

- B) The interested companies / firms are required to submit their EOI submitting the following details / information / documents:
- company/firm profile/history
 - Registration of firm/memorandum and articles of association.
 - Certificate/undertaking for not having any litigation against PDA.
 - Detail of permanent employees and their experience. Number of armed guards registered with the company is to be provided.
 - Refresher training last schedule and frequency.
 - Last three years evidence of income tax returns filed.
 - Valid license of ministry of interior and KP government to run security company.
 - Registration with income tax authorities KP government for sales tax, EOBI & ESSI.
 - Description of fire arms / weapons with documentary proof of arms license.
 - Last three years bank statements and certificates.
 - NOC from the Khyber Pakhtunkhwa government.
 - Audited financial statements for the last three years.
 - Certificate of background checks by Special branch.
 - Clientele list with telephone numbers of the contact persons.
 - Contract may be extended for a period of two years on an annual basis & mutually agreed terms and conditions subject to satisfactory services rendered by the company.
 - Have maximum professional security specialists (Ex defence) on their panel as indirect employees/management staff and the third party guards.
 - Capability to provide maximum ex-servicemen from local areas as per company policy with extensive demonstrated knowledge of existing environmental conditions.
 - Ability to develop logistics capability for security services, patrolling and quick reaction teams integrated with the static grid.
 - Sufficient resources (financial & manpower) with professional management, organization and business support to deliver the required services.
 - Have a training facility for the guards.
 - Security companies able to provide licensed AK-47 weapon.

Note:

1. Number of Guards can be increased or decreased on demand of client.
2. The contract will be for two years.

Interested security Firm/Companies are invited to provide above mentioned information indicating that they are qualified to perform the required services.

Security firms / companies will be selected in accordance with the KPPRA rules.

EOI Proposal will be opened on the same day i.e **19th December, 2016 by 2.00 pm**. One company / firm will not be allowed to submit more than one EOI. The procuring entity reserves the right to accept or reject all EOIs assigning any technical/administrative reasons under Rule 47 of KPPRA rules 2014. Late submitted EOIs shall be rejected & returned unopened.
