Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Project Director, Automation of Pension Payment Project, Finance Department, Peshawar's Tender Notice for Procurement of Miscellaneous ICT Equipment & Other Items.

Dear Sir,

This is with reference to Automation of Pension Payment Project, Finance Department, Peshawar's Tender Notice published in daily "Mashriq" on 27th December, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "The quantity can be increased/ decreased subject to availability of budget/ requirement", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPK Public Procurement of Goods, Works and Services Rules 2014, Page 6 & 7, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:

(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:

Provided that it does not exceed fifteen percent of the original contract value;

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.--- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
