
As per the advertisement, KMU Institute of Medical Sciences, Kohat reserves the right to accept/reject any tender without giving any reason. It is not complying with KPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

*47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
