Sub: Request of clarification of in the light KPPRA Rules by not Announcing
Evaluation Report before Financial Opening for the Purchase of Medical Equipment
at Gajju Khan Medical College, Swabi tender dated 22.07.2016.

Dear Sir,

Transparency International Pakistan has received a complaint from M/s Friends Traders against Tender Notice of Gajju Khan Medical College, Swabi for 'Procurement of Medical Equipment, Instruments and General Items (IFB) Procurement and Installation of Medical Equipment, Instruments and General Items under (NCB)' (Copy Enclosed).

The complainant has made following allegations;

1. That the tender notice of Gajju Khan Medical College, Swabi appeared in the JAHAD newspaper on 22-06-2016 for Procurement of Medical Equipment, Instruments and General Items through single stage two envelop bidding procedure.
2. That evaluation of technical bid was not shared either via email or report up till 26-10-2016. i.e., on the financial opening date. It is in a violation of Chapter V of Miscellaneous Provisions of KPPRA Rules 2014, Rule No.45. Stated as under:


***45. Announcement of evaluation reports.**---Procuring entities shall announce the results of technical bid evaluation in the form of a report before opening of the financial bids, to all bidders. The procuring entity shall also announce the final results of a bid evaluation giving justification for acceptance or rejection of bids at least ten days prior to the award of a contract and place the same on its and Authority website.*

3. That the financial opening has taken place on 26-10-2016 in the presence of all bidders without technical points; therefore complainant was not given the opportunity to clarify their position technically.

Project Director, Gajju Khan Medical College Swabi is requested to kindly examine the complaint and if found genuine cancel and re-tender the as per KPPRA Rules 2014.

Bidding from highly reputed National and International Manufacturers and authorized/sole agents for procuring high quality Medical equipments, Instruments, office equipments, during the financial year 2016-17 through Single Stage-Two Envelopes bidding procedure as per Rule 06 (2 b) of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement Rules 2013.

3. A Pre-Bid Meeting will be held on 16/07/2016 at 11:00 A.M at the address given below. The bidders are requested to thoroughly study the Standard Bidding Documents before the Pre-Bid meeting for any clarification of their queries during the said meeting.

Bids must be delivered at the address given below on or before 11.00 hours on 22/07/2015 (on the next day in case of gazette holiday(s)) and shall be opened in the presence of the bidders or their authorized representatives, who choose to attend at the address below at 11:30 hours on the same date.

5. Firms, shall submit the Bid Security in an envelope along with the financial bids in the shape of Pay Order (PO)/Demand Draft (DD)/Call Deposit Receipt (CDR) equal to 2% of their bid amount in the name of Project Director Gajju Khan Medical College Swabi. The bidders shall submit
