



I am directed to refer to the subject noted above and to inform that following discrepancy has been noticed in Tender advertised in "Daily Aaj" on 18th, May, 2016.


In the advertisement the office has restricted the bidders to supply IT Equipments of specific brand such as (Orient AC), which is in contradiction to the section 23(4) of KPPRA act 2012.

"Each procuring entity shall solicit bids based on performance or functional specification and not on restrictive or proprietary specification of particular brand".

It is pertinent to note that as per Rule 54 of KP Procurement Rules, 2014 *any breach of these rules shall account to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*


Therefore, the department is advised to correct the same accordingly by issuing Addendum / Corrigendum.




