Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, General Manager, HR/ Admin/ Procurement, Water and Sanitation Services Peshawar (WSSP), Peshawar's Quotation Notice for Printing, Supply and Installation of Panaflex for Billboards, Banner, Leaflets and Shields etc.

Dear Sir,

This is with reference to Water and Sanitation Services Peshawar (WSSP), Peshawar's Quotation Notice published in daily "Aaj" on 17<sup>th</sup> December, 2016. It is observed that the advertisement is in violation of the KPK PPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission of bids is given as 26-12-2016, which is 5 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

*34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
