Dear Sir,

This is with reference to Village Council Dartain, Haripur's E-Tender Notice published in daily "Aaj" on 17th December, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 27-12-2016, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Interested Contractors are instructed to obtain user name and password from his own enlistment/registration No for downloading of Tender form and BOQ from the website. (2) 2% earnest money in the shape of deposit at call, issued by schedule Banks of KPK for each work in the name of Nazim VC Dartian Haripur must be accompanied with the tender documents. (3) The Contractor who offer/quoting the rate 10% or more than 10% below on the engineering estimate/BOQ shall attached additional earnest money with the bid @ %age ratio of the offered rates as "below" otherwise the bid shall be treated as rejected and 2% earnest money already deposited will be forfeited and offer should be made to the 2nd lowest, 3rd lowest as the case may be. (4) Attested photo copy of CNIC, valid Registration with Pakistan Engineering Council, Director General LG&RDD and national money tax certificate be attached with tender documents. (5) Sealed bids in original to the undersigned and a duplicate copy thereof to AD, LG&RDD room No-206, A block District Secretariat, Haripur shall be sent through registered RDD Peshawar before the prescribed time mentioned above. The bids received late shall not be entertained, any delay in delivery of tender documents will be the responsibility of the bidders. (6) The Cost estimate of the works are prepared on MRS-2016 Contractors should quote their rate in figures as well as in words in the blank column Contractors shall be bound to execute that particular item free of cost. (7) No above/below rates shall be entertained/accepted and in case the totaling of the bid amount worked out by the Contractor found in correct his bid will be rejected and deposited earnest money will be forfeited. (8) In case bids become tie, the award of Contract shall be decided through a free toss which shall be binding and final. (9) Any disfigure/overwriting manipulation in the tender documents will not be acceptable. (10) The procuring entity may reject any or all the bids after communicating the reasons for rejection at any time prior to the award of contract. (11) If any of the documents found not attached with the tender documents the tender shall be liable to rejection. (12) Other terms and conditions can be obtained from the Office during working hours or can be downloaded from the department's website. (13) The works order shall only be issued against the volume of funds available with VCs/NCs Dartian during current financial years 2016-17 for VCs/NCs ADPs Schemes. (14) Any addition made in Term & Conditions in the MIT advertised in the newspaper will be implemented as per KAPRA Rules.
