Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Police Officer, District Police Office, Mardan's Short Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to District Police Office, Mardan's Short Tender Notice published in daily "Mashriq" on 18th January, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. However, according to KPPRA Rules 2014, Rule No. 33 (5). 'Bid solicitation documents' clause, a set of tender document should be provided to the bidders. Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
