Sub: Violation of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012,
Project Director, Dera Development Authority, Dera Ismail Khan's Tender Notice for
Supply of Miscellaneous Work.

Dear Sir,

This is with reference to Dera Development Authority, Dera Ismail Khan's Tender Notice, published in daily "Aaj" on 19th January, 2017. It is observed that the advertisement is in violation of the KPK PPRA Act 2012.


As per the advertisement, the fee of bidding documents for work of Sr. No. 4 & 5 is issued on non-refundable payment of PRs 10,000/-, which appears costly in light of the Procurement Act and is violation of KPK PPRA Act 2012. According to the Act, Section No. 19, in the 'Public Accessibility' Clause, the tender document fee shall not exceed printing cost. Stated as under:

***19. Public Accessibility.** --This Act, the rules made thereunder, guidelines, forms, bidding documents and/or decisions of Government or procuring entity relating to procurement shall be placed on a web-site of the Authority in addition to the website of the procuring entity or the Government, as the case may be, and which will also provide copies of these documents to the public at a fee not exceeding the cost of printing/reproduction of the documents.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

All bids must accompanied by: a) Bid security in the shape of call deposit (in original) equal to 2% of bid cost in the name of Project Director Dera Development Authority D.I.Khan. b) Attested photo copy of Pakistan Engineering Council 2017 registration in relevant category. c) Attested photo copy of National Identity Card. d) Dera Development Authority renewal for the year 2016-17 challan copy. e) For work at S.No4 to 5, firms shall submit Public Health Engineering Department enlistment/ renewal copy 2016-17. 4. For scheme at S.No 1, a non refundable tender form fee amounting to Rs 5000/- for S.No 2, an amount of Rs 3000/- and for S.No 3, an amount of Rs 2000/- for each tender in the shape of pay order/ bank draft in the name of Project Director DDA D.I.Khan or shall be deposited in Bank of Khyber Main Branch D.I.Khan A/C No 1785-1. The original receipt must be attached with tender form otherwise tender will not be considered in bid documents. 5. For works at S.No 4 to 5, a non refundable tender form fee of Rs 10000/- in the shape of Bank Draft/ Pay order etc in the name of Project Director DDA D.I.Khan must be accompanied with the tender form. 6. The bidders are required to send their bids through courier/registered mail in duplicate in separate envelopes clearly marked as original and duplicate. The original shall be sent to Project Director DDA D.I.Khan and duplicate to Director Technical Khyber Development Authority Khyber. Both the original and duplicate bids shall reach the concerned offices before closing date & time. 7. For work at S.No 1, the eligible contractor/ firms are required to submit two separate sealed envelopes. 1st envelope containing technical information of bid and marked as technical bid while 2nd envelope containing priced bill of quantity (B.O.Q.) clearly marked as Financial bid accompanied with tender form and call deposit. The financial bids of those firms will be opened only who are technical qualified by the competent authority. 8. From S.No 1 to 3 for bid more than 10% below on the estimated cost, additional call deposit/ bank draft equal to 8% of the bid cost in favour of the Project Director DDA shall be enclosed in the sealed bid otherwise bid shall be termed as non-responsive. 9. The tender will be rejected of those contractors whose documents found incomplete/ bogus. 10. If any document submitted alongwith bid documents found false/ bogus the registration of the contractor/ firm shall be cancelled.
