**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Dean, Khyber Medical College, Peshawar's Tender Notice for KMC Photostat Cabin & KMC Book Shop.**

Dear Sir,

This is with reference to Khyber Medical College, Peshawar's Tender Notice, published in daily "The News" on 18<sup>th</sup> May, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, "KMC Peshawar reserves the right to cancel full or part of the tender without assigning any reason". It is not complying with KPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

*47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Scaled tenders for the running of Khyber Medical College Peshawar Photostat cabin and KMC book shop are invited for the period of 03 years, from 05-06-2017 to 4-6-2020 on the following terms and conditions from sales tax registered bidders which should reach the undersigned on or before 01-06-2017 at 12:00 noon which will be opened on the same day at 1:00 pm in the office of undersigned in the presence of interested bidders:-

1. The tender must reach the undersigned in sealed cover through registered post/courier service clearly mentioned on envelop "Quotation for KMC Photostat cabin OR KMC Book Shop".
2. The bid should be on monthly rent basis to be increased 10% in 2<sup>nd</sup> year and 15% for the remaining year.
3. The utility charges such as electricity etc will be paid by the contractor according to actual consumption on the basis of meters installed in the cabin.
4. The contractor will pay monthly rent from 1<sup>st</sup> to 5<sup>th</sup> of each month.
5. A Call deposit of Rs. 10,000/- for KMC Photostat cabin and KMC Book shop in the name of undersigned must accompany the quotation.
6. Maintenance and repair/white and wash etc. of the cabin must be carried out by the contractor.
7. The contractor will not allow any outsider for Photostat/book shop etc
8. College timing will strictly be observed by the contractor from 8:00 am to 3:00 pm.
9. In case the contractor wishes to leave the cabin/book shop, he will serve 3 months notice otherwise his security will be confiscated.
10. In case the administration is not satisfied with the rates, work and conduct of the contractor, the Dean KMC Peshawar, reserve the right to call explanation, impose fine or even cancel the contractor.
11. The undersigned reserves the right to cancel full or part of the tender without assigning any reason.
