Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Nazim/ Secretary, Village Council Dislawar, District Dir Upper's E-Tender
Notice for DWSS, Street Pavement and Boundary Walls Works.

Dear Sir,

This is with reference to Village Council Dislawar, District Dir Upper's E-Tender Notice published in daily "Aaj" on 19th December, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 29-12-2016, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***34. Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

Terms and condition:-

- 1- Tender documents /BOQ can be downloaded prior to the last date/one day before the last date of submission of tender from Local Govt: & Rural Development department web site i-e www.lgkp.gov.pk/tenders.
- 2- 2% earnest money must be accompanied with the tender documents in shape of original call deposit in the name of Nazim Village Council from scheduled Banks. Documents like enlistment copy of LG&RD Department, Registration of PEC, and NIC must be attached with tender form and call deposit for each scheme in a separate envelope highlighting name of work (written over the envelope).
- 3- The tender form and BOQ must be signed by the contractor.
- 4- The successful contractors have to pay stamp duty and all applicable Provincial /Federal govt: taxes issued from time to time.
- 5- The contractors/bidders who quote their bid/rates more than 10% below the engineer estimate shall submit an additional security in the form of call deposit equal to 8% of the bid cost. After commencement of works by the successful bidders 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
- 6- In case the bidder quotes more than 10% below the bid cost and the bid is not accompanied by the additional security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
- 7- The tenders shall be processed according to "above/below system" based on Market Rate System.
- 8- Bid security of some or all the bidders will be retained by the employer till approval of Tender/bid validity period.
- 9- Complete bids (both original & duplicate) must reach the concerned offices on or before the fixed date/time.
- 10- Original tender forms must reach to the office of Nazim Village Council and duplicate must reach to the office of AD LG&RDD Dir Upper before fixed date and time.
- 11- Incomplete /conditional or telegraphic tenders shall not be accepted.
- 12- The department is not bound to provide any machinery/testing laboratory and the total cost on it will be borne by the contractors themselves.
- 13- The Engineer estimates are framed on the MRS 2016.
- 14- Bids will be valid for Ninety (90) days.
- 15- Any bidder who provides incorrect information should be disqualified.
- 16- Any contractor/bidder who submits tender form without original call deposit, their case will be forwarded to high ups for blacklisting.
- 17- In case of bids become tie the award of contract shall be decided through a free toss which shall be binding and final.
- 18- Work order will be issued subject to release of funds under ADP Schemes 2015-16 to Nazim Village Council from Finance Department Govt of KPK
- 19- Authority reserves the right to accept or reject any or all tenders with assigning any suitable reasons.
