Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director General, Sports & Youth Affair, Peshawar's Tender Notice for Supply of Sport Equipment.

Dear Sir,

This is with reference to Sports & Youth Affair, Peshawar's Tender Notice, published in daily "The News" on 18th March, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, two different dates for submission of tenders is given i.e. 28-03-16 and in the table shown it is given as 08-04-16, which has caused confusion regarding actual date. Therefore the advertisement is in a violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS AND CONDITIONS

- The sports gears shall strictly conform to the National / International specifications or as per specification recorded in the bid schedule to the tender.
- No secured advance or advance payment whatsoever shall be payable to the supplier.
- Contracting firms must be tax registered with Government. All applicable taxes will be deducted as per Government rules. Suppliers must invariably mention whether the rates are inclusive of taxes or exclusive of taxes.
- Sealed bid must be accompanied by a bid security for an amount not less than 2% (two percent) of the total tender value (refundable) in the form of Call deposit Receipt (CDR) / Pay Order / Bank Draft or Bank Guarantee issued by any schedule Bank of Pakistan in the name of Director General, Sports & Youth Affairs, Government of Khyber Pakhtunkhwa to be valid for 180 days (one hundred and eighty days).
