Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Secretary/Nazim, Neighborhood Council/ Village Council, Banda Miagan 199, Khyber Pakhtunkhwa's Tender Notice for Construction & Installation Works.

Dear Sir,

This is with reference to VC, Banda Miagan 199, KPK's Tender Notice, published in daily "Aaj" on 19th Aug, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for tender opening/ closing is given as 29-08-2017, which is 5 days short and is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 1) Tender form received will be 12:00 pm & Opening of tender will be at the same day at 2:00 pm. The completion period will be as per work order.
- 2) All the tenders/bidding shall be done on "Percentage Below/Above".
- 3) The following shall be attached with the bids: (i) Enlistment and Renewal Copy in LGE&RDD Department for the Year 2015-16 (ii) Photocopy of CNIC (iii) Power of Attorney (if applicable).
- 4) The 2% Earnest Money as mentioned against each work shall be received in the shape of Call Deposit from scheduled bank in the name of concerned Nazim.
- 5) Tender documents of bidders if found with bogus/false documents will be rejected and their registration shall stands cancelled/blacklisted in addition of forfeiture of earnest money.
- 6) Incomplete bids or without 2% earnest money shall not be accepted.
- 7) Cutting/Over writing in the BOQ/Contract will be termed as defective.
- 8) The limits for below rates shall be followed as per Government rules.
- 9) The contractors/forms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process.
- 10) All pages of the bid/tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.

- 12) No tenders are acceptable through Fax/by hand.

- 14) Sealed bids sent through registered mail/couriers service should reach upto the specified time and date, and will be opened in presence of bidders/representatives.
