Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Dean, Khyber Medical College, Peshawar's Pre-Qualification Notice for Special Repair and M&R Works.

Dear Sir,

This is with reference to Khyber Medical College, Peshawar's Pre-Qualification Notice, published in daily "The News" on 20th June, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, Khyber Medical College, Peshawar reserves the right to accept or reject any application without assigning any reasons thereof and the decision in this regard shall be final and binding". It is not complying with KPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS:

1. Only firms / contractors registered with the DGHS Peshawar / Khyber Pakhtunkhwa Communication & Works Department under category of "A" during 2018-19 and with Pakistan Engineering Council (PEC) valid for the year upto (31/12/2018) and also visible on web site of Pakistan Engineering Council according to the contract amount and having specialization in execution of building works (CE 09, CE 10, EE 04, EE 06.) are eligible to apply for pre-qualification.
2. The firms / contractors are requested to furnish the following information/documents with evidence along with their applications written on their printed pads.
 - a) Name of the firm/contractor along with address, telephone No, Fax No & E-mail.
 - b) Income Tax Certificate along National Tax Number (NTN) dully cleared by the Tax authorities.
 - c) The firm must registered with Sales Tax Department and also with Khyber Pakhtunkhwa Revenue Authority (KPRA)
 - d) Details of Technical / Non Technical Staff, Skilled / Un-Skilled on permanent / part time along with CNIC and contact address / telephone no etc and detail of Machinery / Equipments.
 - e) Detail of General Works executed in the last five years duly certified by the concerned Departments indicating scope of works, completion, cost and time taken for completion of the work.
 - f) Affidavit (original) on stamp paper properly attested by the Oath Commissioner, to the effect that the firm has neither been black listed by any Agency / Department nor involved in any subversive activities, and the statement referred above is correct and nothing has been kept hidden intentional.
 - g) Bank certificate to show financial soundness (Bank statement / Guarantee for the last three years)
 - h) Detail of works where penalty imposed, if any.
 - i) Valid registration of enlistment of required category with the Khyber Pakhtunkhwa Communication & Works Department and Pakistan Engineering Council.
 - j) Any additional information which firms / contractors want to submit in support of consideration towards pre-qualification.
3. Interested firms / contractors may apply to the undersigned latest by 09/07/2018, along with the above information dully supported with relevant documents for pre-qualification. No application / documents will be entertained, delivered by hand.
4. Incomplete application without supporting documents or received after due date will not be entertained.
5. The undersigned reserves the right to accept or reject any application without assigning any reasons thereof and the decision in this regard shall be final and binding.
6. If any firm/contractor is rejected then they will have no right to sue in court of law.
