Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Highway Division, Swat's NIT Notice for Construction/ Widening/ Improvement/ Rehabilitation of Roads & Bridges.

Dear Sir,

This is with reference to C&W Highway Division, Swat's NIT Notice, published in daily "Aaj" on 17th October, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "only the last date & time of closing of bids is mentioned without stating the date & time of opening of bids that shall also be on the same day". It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;

Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the RFP under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
