Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Deputy Commissioner, Lower Dir's Tender Notice for Purchase of Laptop with
Bag, Digital Camera & Printer

Dear Sir,

This is with reference to Deputy Commissioner, Lower Dir's Tender Notice, published in daily "The News" on 21st October, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, "Number of items increased or decreased as office requirement and budget availability", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Rule No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:
(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:
(i) repeat orders within a period of six months:
Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- The successful firm/suppliers shall deposit 8% of the tender offered as security in the shape of bank draft/call deposit after acceptance of tender.
- Tender forms can be obtained by the authorized representative of the firms/suppliers from the office of District Officer, Finance & Planning, Dir Lower during office hours.
- Photocopies of the tender forms not signed by the District Officer (F&P), Dir Lower or tender offered on any other format will not be accepted. Besides Tenders forms submitted by hands will also be rejected.
- The firm/suppliers shall be bound to supply the items within 15 days after issuance of supply order from the undersigned.
- Substandard items, if any, will not be accepted and the firm/supplier will be bound to replace such items according to the specifications within a week time positively, otherwise supply order shall stand withdrawn/cancelled and the security forfeited.
- Prices/rates offered in the tender forms shall be valid up to 30 June, 2017.
- Government taxes will be deducted from the bills in the light of the prevalent Government rules.
- Transportation/loading and unloading of the items to be supplied will be the responsibility of the successful supplier/firm
- Tender forms shall be sent to office of District Officer Finance and Planning, Dir Lower on or before the due date. No tender form will be accepted after the due date and time.
