

Subject: Complaint against a Vague Traffic Violation Ticket Code #45

Dear Sir,

TI Pakistan has received a complaint from Mr. Hamid Gul, a driver, against a vague traffic violation code #45 mentioned in traffic violation ticket. The detailed complaint along with annexures is attached for your ready reference and is self-explanatory.


The complainant alleges that on 22<sup>nd</sup> October 2016, when he was driving his passenger vehicle No. C2487 on Chitral road, he was signaled to stop by a traffic policeman near Taimrgarah. He stated that he was given a violation ticket No. 15695393, Book No.156957 bearing violation code No. 45 with a fine of PKR 315. He further alleges that when he inquired about the violation he committed, the traffic policeman did not specify it.

The traffic violation code No. 45 (Annexure-A) seems to be a vague code because it does not specify the offence/violation clearly. It reads "Qanoon ya rules ki khilaf warzi jis ka liya koi saza muqarrar na ho." According to the description of the code 45, if the violation does not have any punishment then why the drivers are fined. This code gives the traffic officials discriminatory powers to challan any person who may not have committed a violation. The traffic police department must specify all violations possible and its fines on the violation ticket. The rest of the 65 violation codes are clear and specific.

Transparency International Pakistan would greatly appreciate if you would kindly look into this matter and address it by either clearly mention the code No 45, or remove it from the traffic challan.

TI Pakistan is striving to have Rule of Law in Pakistan which is the only way of eliminating corruption and have good governance in the country.
