Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, Public Health Engineering Division, D.I. Khan's Tender Notice for Solar Based Water Supply Schemes.

This is with reference to PHE Division, D.I.Khan's Tender Notice published in daily "Mashriq" on 21<sup>st</sup> January, 2019. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of bids is on 31-01-2019, which is 4 days short. It is a violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Technical Design should be based on Hydraulic parameters of the scheme provided in the bidding documents & rates should be quoted accordingly in financial bid.
- 3) Technical bids must be accompanied by a bid security equal to 2% of the estimated cost of each scheme in shape of call deposit along with the stamp duty. For Financial Bid beyond 10% below, additional Call 8% on the Estimated cost of each scheme separately shall also be enclosed, otherwise financial bid shall be termed as non-responsive.
- Incomplete / conditional bid or bid with unattested cutting/overwriting/disfiguring will not accepted.
