This is with reference to PEDO, Peshawar's RFP Notice, published in daily "The News" on 20th March, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per the advertisement, "PEDO reserve the rights to accept or reject any or all the bids without assigning any reason". Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.47 (1). Stated as under;

47. Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the RFP under the prescribed procedures or issue a corrigendum and extend date accordingly.
