Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Medical Superintendent, DHQ Hospital, Timergara, District Lower Dir's Tender Notice for Procurement of Bio-Medical Equipment and Furniture.

Dear Sir,

This is with reference to DHQ Hospital, Timergara, District Lower Dir's Tender Notice, published in daily "Mashriq" on 22nd April, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, "Quantity of items can be increased/ decreased", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Rule No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:
(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:
(i) repeat orders within a period of six months:
Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

1. The office of the Medical superintendent DHQ Hospital Timergara Dir Lower invites sealed bids from highly reputed national and international manufacturers and authorized/ sole agents (registered with DGHS KPK Peshawar) for procurement through single stage two envelopes bidding procedure as per rule 6(2)(b) of the KPK procurement of Goods, works and services Rules 2014, during financial year 2015-16.

3. A Pre-Bids meeting will be held on 05-05-2016 at 10:00 AM at DHQ Hospital Timergara Dir Lower. The bidders are requested to thoroughly study the standard bidding documents before the pre-bidding meeting for any clarification of their queries during the meeting.
4. Firms pre-qualified or registered with DGHS KPK Peshawar shall submit bids security @2% and unregistered firms shall submit bids security @ 5% of their financial bids in form of Pay Order / Demand Draft/ Call Deposit Receipts in the name of Medical Superintendent DHQ hospital Timergara Dir Lower.
5. The bidders shall submit an undertaking in their technical bids that the requisite bids security be included in their financial bids.
6. Technical Bids shall be considered as Tender Inquiry or Part of the Tender inquiry.
7. Bids shall reach on or before, 12-5-2016 and will be opened on the same date at 11:00 AM, in front of the owners/ authorized representatives of the firms and purchase committee.
8. Bids shall be valid upto 30-06-2016. Quantities of items can be increased/decreased
9. Bids received late will not be entertained.
10. The bidder are requested to quote their best and final price of the equipments and furniture as per specifications mentioned in the standard bidding documents/ Tender inquiry, as no negotiation on the price is allowed in the KPPRA Rules 2014
11. Income tax, sale tax and custom duties etc will be deducted as per standard rules.
12. The competent authority has the right to reject any or all bids by assigning reason under Rule 47 of Khyber Pakhtunkhwa Procurement Rules 2014.
13. For all the electrically operated equipment either the design should be clear enough to compensate for the low voltage fluctuations or should have built-in external AVR system (UPS/battery / serve motor stabilizer system).
