**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services  
Rules 2014, Secretary/Nazim, Village Council Ghora Bazgran, Abbottabad's E-Tender  
Notice for Miscellaneous Works.**

Dear Sir,

This is with reference to Village Council Ghora Bazgran, Abbottabad's E-Tender Notice published in daily "Mashriq" on 23<sup>rd</sup> March, 2017. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, no response time is mentioned which is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

*34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Tender form and BOQ can be downloaded by the original; available on the LG & RDD web site ([www.lgkp.gov.pk](http://www.lgkp.gov.pk)) after two days of publishing tender in newspaper.
- Tender document/ form fee (RS 1000 for work value up to 10 Lac and for above @0.50% at estimated cost shall be payable through schedule bank of KPK Chilian (Non-refundable) in the name of Nazim VC Ghora Bazgran Havelian Abbottabad the original receipt will be attached with tender document, otherwise the bid will not be entertained. 2<sup>nd</sup> earnest money in the shape of deposit at call, issued by schedule Bank of KPK for each work in the Nazim VC Ghora Bazgran Havelian Abbottabad must be accompanied with the tender documents.
- The contractor who offer/quoting the rates 10% above on the BOQ shall attached additional earnest money with the bid at the ratio of the offered rates as "above" otherwise the bid shall be treated as rejected and 2% earnest money already deposited will be forfeited and offer should be made to the 2<sup>nd</sup> lowest, 3<sup>rd</sup> lowest as the case may be.
- The tender document should be complete in all respect and incomplete document will not be acceptable for consideration.
- The following documents is required to be submitted with the application/tender form
  - Enlistment copy and renewal with the application/tender form
  - CNIC copy of the bidder.
  - Copy of registration and renewal of Pakistan Engineering Council for the current year.
  - National income Certificate.
- Bidder found with bogus document, their tender will be rejected their cases will also be forwarded to higher ups for black listing.
- The contractors/ firms will have to start work immediately (within one week) after the issuance of work orders, otherwise their call deposits will be forfeited and they will be allowed to participate in any tendering process.
- The processing entity may rejected all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or proposal, the ground for rejection of all bids or bids or proposals as per KPPRA rules.
- The estimated of the works are prepared on MRS-2016. Contractor should quote their rates as below/above percentage in figures as well as in words in the respective columns, and only the first two figures after decimal of the rates will be considered during evaluation of the bids. In case of blank column the contractor shall be bound to execute that particular items free of cost.
- According to the notification by Khyber Pakhtunkhwa Finance Department, in the case a contractor submit his bid more than 10% below or above. He is bound to submit additional 8% earnest money.
- Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
- Tender /bids should reach the office of the concerned council as mentioned above through courier/registered post before the opening time. Responsibility of late delivery will not rest upon this office.
- The duplicate copy of sealed tender must be sent to concerned Assistant Director LG&RDD office for record purpose before the closing date and time of the tender.
- Other terms and condition can be obtained from the office during working hours and can be downloaded form the department's website.
- Any additional of amendment made in terms and condition in the NTT advertised in the newspaper will be implement as per KAPPRA rules.
