Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Building Division, Swat's E-Bidding Notice for Miscellaneous Works.

Dear Sir,

This is with reference to C&W Building Division, Swat's E-Bidding Notice, published in daily "Nawaiwaqt" on 23rd February, 2018. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for submission/ opening of bids is on 6-03-2018, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Technical proposal should accompany the following:
 - Bid Security 2% of the Estimate Cost in the shape of call deposit in (original) enclosed in Technical proposal. The E-bidders who quote their bids/ rates more than 10% below the Engineer's estimate shall also enclose an additional security in the form of call deposit equal to 8% of the Estimated Cost in Technical proposal.
 - Enlistment Order of C&W Department (photo copy).
 - Renewal of registration for CPY 2017-18 (photo copy)
 - National Identity Card (CNIC photocopy)
 - Valid Pakistan Engineering Council Registration copy for current calendar year
 - Form H of the Company / Firm.
 - Documents showing general capabilities, financial soundness, general and relevant experience, personnel capabilities, equipment capabilities and Income Tax/NTN Certificate etc.
 - Any other documents to support the technical bid.
- After commencement of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e. 25% to be released after completion of the project and so on. In case the bidder quotes more than 10% below the Engineer Estimate and the bid is not accompanied by the additional bid security then bid shall be considered as non responsive.
- All the bidding will be through E-bidding system. Technical bid should be in sealed envelopes clearly mark "Technical Bid". Technical bids shall be submitted through computer before closing time.
- The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as in MRS items.
- Technical evaluation will be carried out with pass/fail threshold. Passing criteria, includes, PEC Registration Enlistment with C&W Department, Tax Payer proof, Relevant experience in past, 05-years, Performance, Technical Personnel, required Equipment, Financial status, Auditors report, Managerial capabilities, Litigation status etc.
- Financial bid shall be filed online. Complete bids must reach the concerned Offices on or before the fixed time. The CDR or additional security (if required) shall be enclosed in the Technical proposal.
- Any Electronic Bidder who provides incorrect information shall stand disqualified and debarred.
- Time allowed for the completion of the work as specified in the BFF shall start from the issuance of LOA.
- Electronic bids validity period is 90 days.
- Successful bidder should sign the agreement with the department within twenty eight (28) days after acceptance of bid.
- Call Deposit of Scheduled Banks shall be acceptable.
- If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through draw.
- Technical Bids will be opened after 30 minutes of closing time in the presence of bidders/ their representative who choose to be draw.
- Financial electronic bids will be opened on **16.03.2018**
- The employer has the authority to reject any bid or all the bids assigning cogent reasons.
- Bid security of 1st, 2nd & 3rd lowest bidders will be retained by the employer till approval of bid.
