Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, District Health Office, Charsadda's Tender Notice for Purchase of Bed Nets Imported.

This is with reference to District Health Office, Charsadda's Tender Notice, published in daily "The News" on 24th July, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. Any items rejected by purchase committee during verification will be replaced by the firm concerned and supply should be made according to specification. Must bring sample on tender day & best quality will be preferred.
3. The supply should be made for local items within 30 days and imported within 60 days after the receipt supply orders otherwise penalty should be imposed according to the KPPRA rules.
4. Tender must be computerized; hand written or any cutting will be rejected on the spot.
5. The call deposit will be verified from concerned bank in case bogus call deposit legal action will be initiated against concerned firm.
6. The payment will be made after physical verification and inspection of items.
7. Sale Tax, Income Tax will be deducted according to the Government rules. Sale tax, Income tax and professional tax certificate must be enclosed.
8. The tender rates will be valid up to 30th June 2018.
