**TERMS & CONDITIONS:**

- (1) All enlisted contractors of LCB having registration / enlistment renewal for the current year shall offer their bids by quoting rates online.
- (2) Option of printing of tenders will be visible only to enlisted contractors on providing online percentage on above / below along with amount, bank & date of earnest money and additional security in case of more below than 10% and agreeing with terms & conditions of tender.
- (3) All enlisted contractors have an option to withdraw their bids online up to closing time of tender, if they intend not to participate in bidding.
- (4) In case they have applied rates online, then they shall be compelled to submit documents along with requisite documents, otherwise will be liable to be declared as blacklisted.
- (5) Any tender or offer of works made by any enlisted contractor without filling bids online shall be null & void henceforth.
- (6) The contract shall be awarded only to the lowest bidder & also shall be issued printed work order through new E-Tendering system & any work order issued by this TMA without E-tendering system shall be null & void henceforth.
- (7) After opening the tender a Tentative Comparative Statement online shall be issued at the time which will not be considered as final comparative statement of the scheme & the final comparative statement will be prepared after secreting of the bidding documents by secreting committee.
- (8) The BOQs for E-Tendering shall be uploaded within five days of publication of advertisement in the national dailies positively.
- (9) The tender documents should be complete in all respect while submitting tender forms the following documents must be attached with the tender documents.
  - a. 2% earnest money in the shape of Original Call Deposit in the name of Tehsil Municipal Officer & an additional bid security in shape of call deposit @ 8% in case of quoting more than 10% below rates according to the online New E-Tendering System also must be accompanied by the bidding documents, in case of non-compliance the tenders will be rejected accordingly.
  - b. The 8% bid security will be returned to the contractor after work done as per laid down procedure as enshrined vide KPPRA Notification NO.KPPRA/M&E/Estt/1-5/2016 dated 24/5/2016.
  - c. Legible copy of Registration and Renewal of license from Local Council Board and Pakistan Engineering Council for the current year.
  - d. Attested CNIC copy of the contractor.
- (10) If any contractor submits bogus documents/false information with the bidding documents, his tender will be rejected and legal action will be initiated against him.
- (11) Sealed bids in original & in duplicate along with requisite documents in two separate envelopes in the name of Tehsil Municipal Officer, TMA Serai Naurang and Secretary Local Council Board should be sent through post / registered courier service, which must reach the office before prescribed date & time mentioned in the tender notice. Bids or tenders received after the prescribed date and time will not be entertained.
