Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director Works, Gomal University, Dera Ismail Khan's Tender Notice for the P/Laying and Fixing of Razor Wire.

Dear Sir,

This is with reference to Gomal University, Dera Ismail Khan's Tender Notice, published in daily "The News" on 23rd July, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

1. As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 01-08-2016, which is 5 days short and it is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***34. Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*


2. Also, the date of submission of tender is given as 01-08-2016, while the opening of bids is given as 02-08-2016. Therefore the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

***37. Submission of bids and bid opening:** — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

In each Or by Draft (NON REFUNDABLE) on submission of application showing permanent postal address of the Firm/Contractor along with the following documents .
- The application shall accompany of the following documents.
 - Photocopy of Registration with Pakistan Engineering Council valid up to last date of Calendar.
 - Photocopy of National Identity card.
 - Financial Statues.
 - Registration with C&W Department.
 - Litigation & arbitration certificate.
 - The income tax certificate from department showing tax payment during last three years.
 - @ 2% of contractor bid.
- Earnest money to Rs. @2% of contractor bid /- in shape of call deposit in the name of Director works GomaluniversityD.I.Khan must company with the tender.
- The person whose name exists in from ll/partnership deed will only be entitled to sign the tender form. BOQ and all other contract documents no proxy will be allowed to participate in the bidding.
- Conditional / Telegraphic tender shall not be entertained.
- In case of bid below the engineering estimate / BOQ. On market rate base. The contractor bidder shall deposit additional security in shape of bank guarantees/ deposit at call as prescribed. To firm up their bids. Further in lieu of Bank Guarantee / deposit at call equivalent insurance coverage of a company having at least AA rating form PACRA/JCR shall also be acceptable from contractor/ bidders quoting up to 10% below on engineering estimate /BOQ. These guarantees will be discharge on expiry of the defective liability period of the contracts. In case of failure by depositing additional sum by the due date the 2% earnest money already deposited by him will be forfeited in favor of Gomal University. D.I.Khan .
- Bidding shall be done "Item rate System" in case no rate is filled against any item the same will have to be executed by the contractor at his own cost as per specification further first two decimal digits will be considered for evaluation.
- Rejection of all tenders proposal subject to approval of competent authority of procuring entity the tender accepting authority may reject all tenders. Proposals offers OR quotation at any time prior to the acceptance OR a tender proposal. Offer OR Quotation. However before rejection of tender on basis of bid being unworkable. The bidder shall upon request be given an opportunity to give a detail analysis of workability of his bid.
- Any other information can be had in the office of the undersigned on any working day during office hours.
- If the contractor/ firm supply in the correct information/ documents the defaulter shall be recommended to higher authority for his qualification and black listing.
- the acceptance of a tender will rest with the competent authority Gomal University who reserves the right to reject one OR all the tenders.
- The validity period of tender shall be 90 days.
- The estimated cost shall not be regarded as basis of payment. The payment shall be on the basis of the completion of the work.
- Any correction, cutting and all pages of the tender must be signed by y tenderer.
- The eligible contractors / Firms are required to submit priced bill of quantity (BOQ) clearly marked as financial bid accompanied with the tender form and earnest money in favor of Director works. Gomal University and reach to the office of the Director Works up to 01/08/2016 at 10:AM.
- The tender will open by the Works Committee on 02/08/2016 at 10:00AM.
