- Only typed tender on original prescribing letter pad sealed and signed (every page) should be submitted. Hand written tenders shall not be accepted. The tender should be submitted along with the mentioned valued call deposit (in pak rupees) other wise the tender shall not be acceptable. Cash/cheque and the reference of old call deposit will not be acceptable.
- Samples of the quoted items should be produced by the bidders before Selection Committee. In case failure the bid, for the product shall not be considered.
- The bidder shall be bound to ensure the supply of the said order at earliest after the receipt of order but not later than one month. In case of failure the firm shall be dealt as per contract agreement.
- If the bidder is involved in any court affairs. In case of any dispute with HMC or any other hospital his tender will not be considered.
- The income tax sales tax will be deducted as per rules.
- No conditional tender will be acceptable.
- The successful bidder will be bound to submit the agreement on a stamp paper of Rs. 500/- With in fifteen days.

- By hand tender shall not be acceptable.
