Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Division, Haripur's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to C&W Division, Haripur's Tender Notice, published in daily "Aaj" on 25th July, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of tenders is given as 30-07-2018, which is 9 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2- Bid documents including instruction to bidders can be downloaded upto one day prior to the opening date from C&W web site (www.cwd.gko.pk).

INSTRUCTIONS TO BIDDERS

(Single Stage Single Envelop E-Bidding System)

- The bidder shall submit 2% Bid Security of the Estimated Cost in the shape of deposit at call (Original) half an hour before closing date and time.
- The bidders who quoted their bids / rates more than 10% below the Engineering estimate shall submit an additional security in the form of call deposit equal to 8% of the Estimated Cost. After commencement of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank. This additional security shall be released to the bidders in four installments i.e. 25% to be released after completing 25% of the project and so on. In case the bidder quotes more than 10% below the Engineer's Estimate and the bid is not accompanied by the additional bid security then bid shall be considered as non responsive.
- If the performance bond or bank guarantee (whichever the case may be) is not provided by the bidder in the required period, the bid security of the defaulting bidder will be forfeited.
- Electronic bids should be submitted electronically on or before the fixed date / time.
- Electronic bidding shall be done on "Above / Below" system on BOQ / Engineer's estimate, based on the MFS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
- Any bidder who provides incorrect information shall stand disqualified and will be debarred.
- Time allowed for completion of the work is as specified in the NIT which will start from the issuance of LOA.
- Electronic bid will valid for Ninety (90) days.
- Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after acceptance of bid.
- Call Deposit of Scheduled Banks shall be acceptable.
- If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bidder will be declared through draw.
- Electronic bid will be displayed by Online E-Bidding System after 30 minutes of closing time in the presence of bidders / their representatives who chose the present.
- The employer has the authority to reject any E-bid or all the E-bids assigning valid reason.
- Bid security of 1st, 2nd and 3rd bidders will be retained by the employer till approval of bid.
