Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director Construction, Pakhtunkhwa Highways Authority (PKHA), Peshawar's Pre-Qualification Notice for Improvement and Rehabilitation of Road.

Dear Sir,

This is with reference to PKHA, Peshawar's Pre-Qualification Notice, published in daily "Nai Baat" on 24th March, 2018. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, no response time is mentioned for the submission/ opening of bids for the bidders. It is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

1. Applications for prequalification under Rule-16 of KPPPRA Rules-2014 are invited from interested firms having valid en istment in PKHA (for year 2017-18) of the required category and financial limit for the following specific contracts to be executed by PKHA:

I. IMPROVEMENT & REHABILITATION OF ROAD FROM KRAPA TO SHAKARDARA (35 KMS) DISTRICT KOHAT SH:

Package-I from 0+000 to 12+000 (estimated cost Rs. 673.492 million) Package-II from 12+000 to 24+000 (estimated cost Rs. 642.037 million) Package-III from 24+000 to 35+000 (estimated cost Rs. 617.954 million)

2. Proposal shall contain bu: not limited to the following:

(a) A letter of intent addressed to Managing Director-PKHA. (b) The title page of brochure shall also contain the nomenclature of the work for which the bidder intends to apply. (c) Complete profile of the company with perfect binding (wire / spiral binding, loose binding shall be avoided). (d) Detail of similar nature works completed during last 05-years supported by completion certificates and work orders of Executing agencies concerned. (e) Detail of Machinery (Tools, Plants & Equipments etc) verified from the Executive Engineers concerned on Stamp Papers or supported with the purchase document / registration of regulatory Department concerned. (f) Particulars of technical staff & engineers and their agreement on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given alongwith their registration number of PEC (In case of graduate engineer). (g) Financial soundness supported by annual audit reports for the last 03 years. (h) Affidavit regarding non-blacklisting of firm. (i) Detail of litigation and arbitration cases (if any) in which the contactor / firm is involved. (j) Income Tax return certificate for latest year and NTN. (k) Any other document or information, which is considered necessary for pre-qualification.

3. A set of pre-qualification documents (including inter alia evaluation criteria, instruction for preparation of firm's brochure and list of documentary evidence required for pre-qualification) are available in the office of undersigned and can be obtained on any working day during office hours on 3ay Order / Call Deposit in the name of Managing Director-PKHA of Rs.1000/- (non-refundable) against each package. These documents can also be downloaded from the official web site of PKHA whereas a Pay Order / Call Deposit of Rs.1000/- (non-refundable) on account of fee of the documents against each package shall be annexed with application failing which the application will not be considered.

4. Proposals should contain the registration with PEC valid upto 30/03/2018.

5. Separate proposal sealed in separate envelope should be submitted against each package.
