Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services  
Rules 2014, Director Culture, Directorate of Culture, Khyber Pakhtunkhwa's Re-Tender  
Notice for Printing of Cultural Manuscripts.

Dear Sir,

This is with reference to Directorate of Culture, Khyber Pakhtunkhwa's Re-Tender Notice, published in daily "Aaj" on 26<sup>th</sup> May, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, "Standard size of the book is 200 pages per book which may increase or decrease", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Rule No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:*

*(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:*

*(i) repeat orders within a period of six months:*

*Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

## RE-TENDER NOTICE

Sealed tenders are invited from the registered and well reputed printers/ publishers of khyber Pakhtunkhwa, for printing of Cultural Manuscripts (Pashtu & Urdu). The tenders should reach office of the undersigned up to 12/06/2016, at 12:00 pm. which will be opened on the same date at 02:00 pm in presence of authorized representatives of the firms.

The Terms and Conditions are as under:-

- i. Standard Size of the Book is 200 pages per book (which may increase / decrease) and the tenders should be on the basis of rates per 200 pages books. However, in case of increasing only per leaf rate shall be considered without cover & binding cost.
- ii. Two tiers of binding shall be followed i.e. stitches & glue.
- iii. Size of the Book shall be 5.5 x 8.5.
- iv. Quality of paper should be 80 gram, offset imported 01 color printing and should be printed on coated plates.
- v. Each book will be @ 500 copies.
- vi. Title 04 color, standard hard binding on ghatta with lamination.
- vii. only those bidders can apply who have their own machinery / setup.
- viii. Advance payment shall not be asked for.
- ix. Supply shall be completed within 30 days, in case of failure, a penalty equal to 01% of the total cost of supply order will be imposed per day till the full completion of supply.
- x. Taxes will be deducted from the bill as per Government rules.
- xi. The purchase committee will reject the provided items if they are not in accordance to the specification. in such case the firm will not claim the cost.
- xii. The tender should accompany by a call deposit of 02% of the total cost.
- xiii. The committee has the right to reject the whole tenders or partially by assigning genuine reasons.
- xiv. Prior to final printing a dummy copy along with draft title shall be submitted to the Director Culture, for final approval.
