



State Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director General, Agriculture Department, Government of Khyber Pakhtunkhwa's Tender Notice for Services.

Dear Sir,

This is with reference to Agriculture Department (Extension), Khyber Pakhtunkhwa's Tender Notice, published in daily "The Nation" on 3rd July, 2018. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 12-07-2018, which is 5 days short. It is a violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of providing information to the concerned authority with request to re-consider the matter under the prescribed procedure or amend advertisement accordingly.
