Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014 and Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012, Director, Directorate of Tourist Services, Peshawar's Tender Notice for Supply of Generator, Mobile and Cameras.

Dear Sir,

This is with reference to Directorate of Tourist Services, Peshawar's Tender Notice, published in daily "Mashriq" on 26th February, 2018. It is observed that the advertisement is in violation of the KPK PPRA Act 2012 and KPPRA Rules 2014.

1. As per advertisement, only the date and time of the opening of tender is mentioned in the advertisement, whereas it should also include the last date and time of submission of tender that shall be on the same day. Therefore the advertisement is in a violation of KPPRA Rules 2014, Rule No.37 (3) & (6). Stated as under;

37. Submission of bids and bid opening: — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received.

(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.


2. Also, Directorate of Tourist Services, Peshawar has restricted the bidders to supply Generator made in Japan/US only, and has not added "or equivalent" with it, which is not allowed under KPK PPRA Act 2012, Section No. 23 (4). Stated as under;

23. Bid Solicitation documents --- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
