Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director General Sports, Khyber Pakhtunkhwa's Tender Notice for Outdoor /Venue Branding.

Dear Sir,

This is with reference to Director General Sports, Khyber Pakhtunkhwa's Tender Notice, published in daily "Aaj" on 25th February, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission/opening of tenders is given as 08-03-2018, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.13 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

(2) Bidding documents can be obtained from the office of Director General Sports, Peshawar Sports Complex Peshawar Cantt on any working day in office hours till 2 pm. (3) Bids must be delivered at the address given below at or before 01:30 PM on 08th March, 2018 and shall be opened by the Committee in the presence of the bidders or their authorized representatives, who choose to attend at the address below at 02:00 PM on the same date.. (4) Sealed bid must be accompanied by a bid security for an amount of Rs. 50,000/- in the form of Call deposit Receipt (CDR) / Pay Order / Bank Draft issued by any schedule Bank of Pakistan in the name of Director General, Sports, Government of Khyber Pakhtunkhwa to be valid for 90 days (ninety days). (5) The bidders shall submit an undertaking/affidavit in their Technical Bids that the requisite Bid Security is included in their Financial Bid without mentioning the amount. Late bids will be treated as nonresponsive. (6) The Bidders are requested to give their best and final rates for as per specifications given in Standard Bidding Documents inclusive of all taxes. (7) Conditional, incomplete, unsigned and bid filled with led pencil will not be accepted. (8) The purchase committee reserves the right to cancel one or all bids with cogent reason.
