Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director, Institute of Kidney Diseases, Peshawar's Tender Notice for Civil Works.

Dear Sir,

This is with reference to Institute of Kidney Diseases, Peshawar's Tender Notice published in daily "Ajj" on 26th February, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 05-03-2018, which is 6 days short. It is a violation of KPPRA Rules 2014. Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- On submission of written application Bidding documents/ TORs can be obtained from Facilitation/ Maintenance Section institute of Kidney Diseases Peshawar during office hours.
- All tender shall be processed according to "above/Below system" on BOQ (both in word and in figures) based on MRS 2017 and hence Above/ Below/At par should be applied and must be written on tender form as well as on BOQ. The word "AT PAR BOQ" should not be written on tender form.
- The Financial Bids shall be accompanied with the Earnest money / Bid security @ 2% of estimated cost in favor of the Director Institute of Kidney Diseases Hayatabad Peshawar in shape of Call Deposit.
- The contractors / Bidders who quote their bids / rates more than 10% Below the Engineer's Estimate shall submit an Additional Security in the form of call deposit equal to 8% of Estimate Cost After commencements of work by the successful bidders 8% call deposit may be replaced with bank Guarantee of the same amount from the bank.
- In case the bidder quotes more than 10% below the Estimated Cost and the bid is not accompanied by the additional security than the bid shall be considered non responsive and the second lowest (bidders and so on well be considered accordingly.
- Bid must be delivered at the address given below at or before 10:00 am on 06/03/2018 through registered courier services. Any conditional, incomplete, hand delivered or received after the due time will not be accepted.
- Tender will be opened in the presence of the Contractors or their authorized representatives to attend at the address below at 10:30 am on the same date by the IKD Tender Opening / Selection Committee.
- Taxes will be deducted as per rules.
- In Case of equal bids 1st, 2nd and 3rd etc, the lowest bidder would be decided through draw by the Tender Opening / Selection Committee, which shall be final and binding upon the bidders.
- Any item not reflected in the BOQ and required at the site, shall be paid in accordance with MRS 2017, subject to prior approval of the competent authority as per contract agreement
- Bid security of 1st, 2nd and 3rd bidders will be retained by the employer till approval of bid or bid validity period.
- The procuring entity may reject all bids at any time prior to the acceptance of a bid as per KPPRA Rules 47 (i).
