Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Hospital Director, MTI, Khalifa Gul Nawaz Hospital, Bannu's Tender Notice for Local Purchase of Drugs, Disposable, Medical Devices, Sutures/ Implants and Other Items.

Dear Sir,

This is with reference to MTI, Khalifa Gul Nawaz Hospital, Bannu's Tender Notice, published in daily "Mashriq" on 24th May, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 2 A Pre Bid meeting will be held on 11:00 am 31-05-2018 in the office of the undersigned. The bidders are requested to attend the meeting to discuss the procedure of bidding, however, non-participation will not effect the date of tender submission
- 3 The bidder must have retail license.
- 4 The firm must be registered with income tax department.
- 5 Rates will be applicable till 30-6-2019.
- 6 Single Maximum discount on the basis of percentage must be quoted on the retail price for medicine & current market rates for the non medicines items, which shall not be higher than the acceptable open market rates.
- 7 Rates must be typed, hand written rates will not be accepted
- 8 Pharmacy/Medical Stores shall submit the bid security amounting to Rs.20000/- which is likely 2% of the total bid amount in the name of Hospital Director Medical Teaching Institution Khalifa Gul Nawaz Teaching Hospital Bannu.
- 9 The Purchase committee has full power to amend/add any clause of terms & Conditions or accept/reject any tender with valid reason.
