Dear Sir,

This is with reference to Islamia College Peshawar, Peshawar's Tender Notice published in daily "Aaj" on 25th November, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement Regulatory Authority Act 2012.


As per the advertisement, the fee of complete set of bidding documents for work is issued on non-refundable payment of PRs 10,000, which appears costly in light of the Procurement Act and is violation of KPK PPRA Act 2012. According to the Act, Section No. 19, in the 'Public Accessibility' Clause, the tender document fee shall not exceed printing cost. The Section is quoted below for your reference;

19. Public Accessibility. --This Act, the rules made thereunder, guidelines, forms, bidding documents and/or decisions of Government or procuring entity relating to procurement shall be placed on a web-site of the Authority in addition to the website of the procuring entity or the Government, as the case may be, and which will also provide copies of these documents to the public at a fee not exceeding the cost of printing/reproduction of the documents.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Tender & Conditions:

(1) Tender will be opened in office of the undersigned on the above date in the presence of the authorized dealers/manufactures/contractors/representative that may care to be present. (2) Original bid security in the shape of call deposit @ 2% in the name of Project Director, ICP shall accompany with the bid. (3) Bidding shall be done on "Item Rate System", bidders should fill their own rates/amount in the blank columns against each items of the BOQ. In case no rate is filled against any item, the same will be executed by the contractor at his own cost as per specification. Furthermore 2-decimal digits will be considered for evaluation. The relevant bidding documents i.e. specification drawings etc. can be purchased from the office of the undersigned. (4) The contractors quoting their rates more than 10% below on estimated cost, the contractors will have to deposit 8% additional call deposit along with tender form as per Chief Minister Secretariat KPK letter No. Sovi/CMS/KPK/1-13/2016/4264-70(WE) dated 8.4.2016. In case the contractor quotes their rates more than 10% below and the bid is not accompanied by the 8% additional call deposit, then the bid will be considered as non-responsive. (5) Conditional tenders are having any disfiguring/overwriting and manipulation will be straight away rejected. (6) All types of materials testing expenses are the responsibility of contractor/firm. (7) In light of schedule-II to the KP Finance Act, 2013, sales tax on services will be deducted @ 5% of the gross amount. Moreover, 1/5th of the 5% amount of sales tax from the contractors, registered with KPPRA & the whole amount of the sales tax from those who are not registered with the KPPRA will be deducted. (8) In case bids of two or more bidders are found equal after evaluation, the lowest bidder shall be decided through toss amongst them. (9) A complete set of bidding documents may be obtained by an interested eligible bidders on submission of written application from the office of the undersigned on cash of Rs.10000/- in the working hours one day prior of submission of forms/documents. (10) All government taxes will be deducted as per rules. (11) The consultant will be responsible for any deficiency in the tender documents. (12) The competent authority reserves the right to accept or reject any or all tender with solid justification in light of KPPRA rules.
