Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Executive Engineer, C&W Highway Division, Mardan's Pre-Qualification Notice for Construction/ Rehabilitation of Roads.

Dear Sir,

This is with reference to Executive Engineer, C&W Highway Division, Mardan's Pre-Qualification Notice published in daily "The New" on 22nd October, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "no pre-qualification document is issued for bidders and it is just mentioned that any other information can be obtained from the office". However, according to KPPRA 2014, Page 18, the 'Pre-qualification process' clause, a set of prequalification document that includes evaluation criteria should be provided to the applicants. The Rule is quoted below for your reference;

Pre-qualification process.--(1) The procuring entity engaging in pre-qualification shall announce, in the pre-qualification documents, all information required for pre-qualification including instructions for preparation and submission of the pre-qualification documents, evaluation criteria, list of documentary evidence required of contractors or consultants to demonstrate their respective qualifications and any other information that the procuring entity deems necessary for pre-qualification.


(2) The procuring entity shall provide a set of pre-qualification documents to any contractor or consultant, on request and subject to payment of document fee if applicable, which shall not exceed cost of printing and providing the documents.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

***Mis-procurement.**— Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.*
