Dear Sir,

This is with reference to Directorate of Reclamation and Probation, Khyber Pakhtunkhwa Peshawar's Tender Notice published in daily "Mashriq" on 21st December, 2015. It is observed that the advertisement is in violation of the KPPRA Act 2012.

As per advertisement, the undersigned has restricted the bidders to supply Laptop of Core (i-5/ i-7) which is from Intel and has not added "or equivalent" with it, which is not allowed under KPK PPRA Act 2012 Section No. 23 (4). Stated as under;

23. Bid Solicitation documents --- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

The above information is forwarded for the purpose of avoiding mis-procurement, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
