Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Hospital Director, Medical Teaching Institute, Lady Reading Hospital,
Peshawar's Tender Notice for Surgical/ Medical Disposables.

Dear Sir,

This is with reference to Medical Teaching Institute, Lady Reading Hospital, Peshawar's Tender Notice, published in daily "Aaj" on 28th December, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of bids is given on 08-01-2016, which is 3 days short, and is violation of KPPRA Rules 2014, Page 18, the 'Response time' Clause. Stated as under:


Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.--- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

The quoted rates should be on F.O.R basis.

TERMS AND CONDITIONS:-

1. The rates approved will remain effective till 30/06/2016
2. Only typed tender on original prescribing letter pad, sealed & signed (Every Page) should be submitted, hand written tender would not be acceptable. The tenders must be according to hospital specification; alternate rates will not be acceptable.
3. The tender must be submitted along with the call deposit as mentioned above; otherwise the tender will not be acceptable. The CDR must be from the Bank of Khyber. However, this condition will not be mandatory where the Bank of Khyber having no branch in reasonable distance.
4. Sample of the quoted items should be produced by the bidder on the date of purchase committee meeting. In case of failure the bid/tender will not be considered.
5. The bidder will be bound to ensure the supply within 30 days or as early as possible on receipt of order, otherwise the supply will be made on risk and cost of successful bidder.
6. The Income Tax, stamp duty and Professional Tax or any other Government tax will be charged as per rules. However, this hospital is exempted from the General Sales Tax. **(Only those firms will be honoured that are on Active Taxpayer's List of FBR).**
7. No conditional tender will be acceptable.
8. The successful bidder will be bound to execute agreement on a stamp paper, with 1" order received.
9. A detailed list of specification of required items can be obtained from the Purchase Cell of MTI/LRH during working hours (Saturday is working day). The specification also available on our website www.lrh.gov.pk.
10. If the successful bidder supplies substandard items and not matching with specification issued from this office will be cancelled automatically.
11. Tender giving company must attach the relevant documents along with their tender that should show that their company is Manufacturer, Importers and authorized dealers of the relevant items.
12. Pre-qualification with Director General Health Services Khyber Pakhtunkhwa, Income Tax, Professional tax and all other required documents must be attached with the tender.
13. If the supply is not done within the period mentioned in the supply order, penalty @ 2% will be charged upto 15 days and beyond 15 days the penalty will be charged @ of 5%.
14. The purchase committee has the right to accept or reject the tender partially or totally and at any stage, after communicating the reason for rejection.
