Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Nazim, Village Council Kakot- 1, Tehsil/District Abbottabad's Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to Village Council Kakot- 1, Tehsil/District Abbottabad's Tender Notice published in daily "Mashriq" on 28th December, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 06-1-2016, which is 5 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

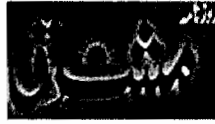

Terms & Conditions

- Tender form/BOQ can be downloaded by the original contractor available on LG&RDD website (www.lgkp.gov.pk)
- The sealed tenders should reach to the office of concerned Council as mentioned above on or below the opening Date / time given against each work.
- The tender documents should be completed and all respect and incomplete documents will not be acceptable for consideration.
- The following documents are required to be submitted with the application/tender form: i) Earnest money to the extent of 2% in the shape of deposit at call in the name concerned Nazim VC Kakot-1 along with stamp duty. ii) Enlistment /Renewal copy with LG&RDD for the current year. iii) CNIC copy of the bidder ii) copy of registration and renewal of Pakistan Engineering Council for the current year. iv. Copy of registration and renewal of Pakistan Engineering Council for the current year.
- Bidder found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher for black listing.
- The contractors/forms will have to start work immediately (within one week), after the issuance of work orders otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process.
- The procuring entity may rejected all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or Proposal, the ground for rejection of the bid or proposals as per KPPRA Rules.
- All the government taxes will be deducted as per prevailing government policy.
- The bidders will have to quote rate on item rate system and will have to quote rate and amount for each and every item. Any blank column of rates will be considered as free of cost.
- The cost estimates of the works are prepared on MRS-2016. Contractor should quote their rates in figures as well as in Words in the respective columns, and only the first tow figures after decimal of the rates will be considered During evaluation of the bids. In case of blank column the Contractor shall be bound to execute that particular item free of cost.
- Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
- Tenders/bids should reach the office of the concerned council as mentioned above through courier/registered Post before the opening time.
- Responsibility of late delivery will not rest upon office.
- The duplicate copy of sealed tender must be set to concerned Assistant Director LG& RDD office for record purpose Before the closing date & time of the tender.
- Any addition made in Terms and conditions in the NIT advertised in the news paper will be implemented In the news paper will be implemented as per KPPRA Rules.
- In case if VC ADP is floated over & above the volume of development funds available with VC bank account The Assistant Engineer, LG & RDD Abbottabad shall issue work-order for those schemes against which funds Are avail
