

A meeting of the District Reconstruction Rehabilitation Committee (DRRC) Swat was held in the office at D. O. P. D. under the Chairmanship of the Deputy Commissioner Swat to discuss and decide the following agenda item:

APPROVAL OF FLOOD PROTECTION IN DISTRICT SWAT.

The XEN, Irrigation Department has prepared 02 Nos. PC-I/Detail Cost estimate of the following developmental scheme for a total cost of Rs. 46.250 million out of saving in KPRP-USAD Sector and submitted to DRRC for approval:

DECISION:

The forum discussed the scheme in depth and after detail deliberation, it was observed that the executing agency has bifurcated the scheme into 02 No. schemes mentioned above which is against the rules as originally the scheme is one. It was further observed that the executing agency has already under taken NIT/tendering process in advance which is also against the law / KEPPA rules. Therefore, the scheme is deferred by the Committee and the executing agency is directed to approach the competent forum for approval of the scheme.
