Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Principal, Government Girls Degree College (KDA), Karak's Tender Notice for Development of Walking Track.

Dear Madam,

This is with reference to Government Girls Degree College (KDA), Karak's Tender Notice published in daily "Aaj" on 26th March, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 30-03-2018, which is 10 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Only registered supplier/ contractors who are on Active Taxpayer List (ATL) of FBR, are eligible to supply/ service to government Department.

The tender is also available at HEMIS website. The documents of the firms i.e enlistment/ renewal receipt, CNIC, NTN, valid Pakistan engineering council license etc. Should be available with the intending contractor at the time of purchase of tenders failing which tender will not be issued. The authority reserves the right to accept/ reject some or all bids under Rules 47 of the KPPRA procurement rules 2014, after assigning valid reason.

TERMS AND CONDITIONS.

- Tenders forms /BOQ can be obtained from the Principal office after publication in the newspaper by the contractors.
- Tender will be available to only to the reenlisted contractor on the basis of above/below along with amount, bank & date of earnest money and additional security in case of below than 10% and agreeing with terms and condition tender registered.
- The documents must be attached with the bids such as i) 2% Earnest Money in shape of original call Deposit in the name of Principal Govt: Girls Degree College (KDA), Karak from scheduled banks, ii) Enlistment copy of C&W Department for the year 2017-18, iii) Registration copy of Pakistan Engineering Council and iv) copy of CNIC for each scheme in a separate.
- Sealed bids must be sent through Registered mail/Couriers services should reached on 30/03/2018 upto 12:00pm and will be opened on the same date at 12:30pm in the prescribe of bidders (if any) by the Tender committee. Delay in delivery of the tender document will be the responsibility of bidders.
- The contractors/ bidders who quotes more than 10% below rate on the engineer estimate shall submit an additional security in shape of call deposit equal to 8% of the estimated cost.
- In case the bidder quotes more than 10% below rate on the estimated cost and the bid is not accompanied by the additional security @8% of estimated cost then the bid shall be considered as no-responsive and the 2nd lowest bidder and so on will be considered accordingly. Resultantly the name of such firm will be sent to LCB for blacklisting.
- The tender shall be proceed according to 'Above/Below system' based on estimate.
- The tender forms and BOQs must be signed by the original contractor.
- Taxes will be deducted as per Government Rules.
- Bid security of some or all the bidder will be retained by the employer till approval of Tender/Bid validity period.
- Complete bids in original must reach to the Principal Govt: girls Degree College (KDA), Karak on or before the fixed date/time (by the firm/contractor).
- The Department will not bound to provide any machinery/ Testing laboratory. The cost of all type of laboratory tests will be borne by the Contractors themselves.
- Any bidder who provides incorrect information should be disqualified.
- In case of bids become tie, the ward of contract shall be decided through a free toss which shall be binding and final.
