Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Principal, Government Degree College Ghazni Khel, Lakki Marwat's Tender Notice for Furniture and Fixture.

Dear Sir,

This is with reference to Government Degree College Ghazni Khel, Lakki Marwat's Tender Notice, published in daily "Aaj" on 28th March, 2018. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tender is on 02-04-2018, which is 9 days short. It is violation of BPPRA Rules 2014, Rule No. 16 (1). Stated as under;

16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Terms and conditions are as follows:

1. (2%) two percent call deposit of the total amount (refundable) shall be attached with the tender form.
2. Each demand will be sent in separate envelope and may be written on the corner of envelope.
3. The successful firm shall deposit 8% of the tender offered as security after the tender is accepted.
4. The selected firms must provide on stamp paper of face value Rs.100 assuring supply of items according to specification.
5. The firm shall be bound to supply the items within 30 days after supply order is placed.
6. The substandard items will not be accepted and the firm will be bound to re supply standard items within a week otherwise the supply order shall stand cancelled and the security forfeited.
7. Price/Rates given in the tender forms (must including GST) & shall be applicable for financial year 2017-2018 only.
8. Income tax and Sales tax will be deducted from the bills according to the prevailing rules and regulations.
