Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Convener Purchase Committee, Islamia College Peshawar, Peshawar's Short Tender Notice for Illumination of Islamia College.

Dear Sir,

This is with reference to Islamia College Peshawar, Peshawar's Short Tender Notice published in daily "Mashriq" on 27th Nov, 15. It is observed that advertisement is in violation of the KPPRA Rules 2014.

1. As per advertisement, "the competent authority has the right to increase or decrease the items." Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Page 6 & 7, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:

(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:

Provided that it does not exceed fifteen percent of the original contract value;

2. Also, "15 days of response time is not given and the last date for submission of bids is given on 02-12-2015, which is 9 days short", and is violation of KPPRA Rules 2014, Page 18, the 'Response time' Clause. Stated as under;

Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.--- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
